Vision Zero is based on the belief that all accidents, illnesses and harm at work are preventable. To implement the Vision Zero strategy, “7 Golden Rules” have been developed to create a culture of prevention at work:

1. Take leadership – demonstrate commitment
2. Identify hazards – control risks
3. Define targets – develop programmes
4. Ensure a safe and healthy system – be well-organized
5. Ensure safety and health in machines, equipment and workplaces
6. Improve qualifications – develop competence
7. Invest in people – motivate by participation

Vision Zero in India

In India, Vision Zero has been adopted by over 160 supporting companies and organizations. Two of these – the Employees' State Insurance Corporation (ESIC) and the Indo-German Focal Point (IGFP) – were honored with the ISSA Vision Zero Award 2023 in the recently held 23rd World Congress on Safety and Health at Work in Sydney, Australia, for exemplarily promoting and implementing Vision Zero in India.

Objectives

The 2024 conference at Bangalore is aimed at CEOs and Senior Managers from national and international companies, safety and health professionals, safety practitioners from companies, policy makers, industry organizations, labour inspectors and OSH auditors, trade unions, employers and universities.
