Visa Invitation Letter

The Foreign Embassy / Consulate / High Commission where the applicant submits the VISA application is expected to follow their usual procedural checks before granting the VISA in question and ICC shall not be responsible in any manner whatsoever for non-issuance of VISA by the concerned authorities. This would mean that the prospective participant will be fully liable for the total charges payable to ICC even if they do not obtain the VISA for any reason whatsoever.
